

# A BILL

To authorize appropriations for fiscal year 2021 for military activities of the Department of Defense and for military construction, to prescribe military personnel strengths for such fiscal year, and for other purposes.

1           *Be it enacted by the Senate and House of Representatives of the United States of America*  
2           *in Congress assembled,*

20 **SEC. 111. ECONOMIC ORDER QUANTITY CONTRACTING AUTHORITY F-35**

21 **JOINT STRIKE FIGHTER PROGRAM.**

22 (a) AUTHORITY FOR ADVANCE PROCUREMENT AND ECONOMIC ORDER QUANTITY.—The  
23 Secretary of Defense may enter into one or more contracts, beginning with the fiscal year 2020

1 program year, for the procurement of economic order quantities of material and equipment for  
2 the F-35 aircraft program for use in procurement contracts to be awarded for such program  
3 during fiscal years 2021 through 2023.

4 (b) LIMITATION.—The total amount obligated in fiscal year 2021 under all contracts  
5 entered into under subsection (a) shall not exceed \$493,000,000.

6 (c) PRELIMINARY FINDINGS.—Before entering into a contract under subsection (a), the  
7 Secretary shall make each of the following findings with respect to such contract:

8 (1) The use of such a contract will result in significant savings of the total  
9 anticipated costs of carrying out the program through annual contract.

10 (2) The minimum need for the property to be procured is expected to remain  
11 substantially unchanged during the contemplated contract period in terms of production  
12 rate, procurement rate, and total quantities.

13 (3) There is a reasonable expectation that, throughout the contemplated contract  
14 period, the Secretary will request funding for the contract at the level required to avoid  
15 contract cancellation.

16 (4) There is a stable design for the property to be procured and the technical risks  
17 associated with such property are not excessive.

18 (5) The estimates of both the cost of the contract and the anticipated cost  
19 avoidance through the use of an economic order quantity contract are realistic.

20 (6) Entering into the contract will promote the national security interests of the  
21 United States.

22 (d) CERTIFICATION Requirement.—Except as provided in subsection (e), the Secretary of  
23 Defense may not enter into a contract under subsection (a) until a period of 30 days has elapsed

1 following the date on which the Secretary certifies to the congressional defense committees, in  
2 writing, that each of the following conditions is satisfied:

3 (1) A sufficient number of end items of the system being acquired under such  
4 contract have been delivered at or within the most recently available estimates of the  
5 program acquisition unit cost or procurement unit cost for such system to determine that  
6 the estimates of the unit costs are realistic.

7 (2) During the fiscal year in which such contract is to be awarded, sufficient funds  
8 will be available to perform the contract in such fiscal year, and the future-years defense  
9 program submitted to Congress under section 221 of title 10, United States Code, for that  
10 fiscal year will include the funding required to execute the program without cancellation.

11 (3) The contract is a fixed-price type contract.

12 (4) The proposed contract provides for production at not less than minimum  
13 economic rates given the existing tooling and facilities.

14 (5) The Secretary has determined that each of the conditions described in  
15 paragraphs (1) through (6) of subsection (c) will be met by such contract and has  
16 provided the basis for such determination to the congressional defense committees.

17 (6) The determination under paragraph (5) was made after the completion of a  
18 cost analysis performed by the Director of Cost Assessment and Program Evaluation for  
19 the purpose of section 2334(f)(2) of title 10, United States Code, and the analysis  
20 supports that determination.

21 (e) EXCEPTION.—Notwithstanding subsection (d), the Secretary of Defense may enter  
22 into a contract under subsection (a) on or after December 1, 2020, if—



1 (1) the Director of Cost Assessment and Program Evaluation has not completed a  
2 cost analysis of the preliminary findings made by the Secretary under subsection (c) with  
3 respect to the contract;

4 (2) the Secretary certifies to the congressional defense committees, in writing, that  
5 each of the conditions described in paragraphs (1) through (5) of subsection (d) is  
6 satisfied; and

7 (3) a period of 30 days has elapsed following the date on which the Secretary  
8 submits the certification under paragraph (2).

7 **SEC. 311. REGULATION OF DISCHARGES INCIDENTAL TO THE NORMAL**  
8 **OPERATIONS OF A VESSEL OF THE ARMED FORCES UNDER THE**  
9 **FEDERAL WATER POLLUTION CONTROL ACT.**

10 Section 312(n)(6)(B) of the Federal Water Pollution Control Act (33 U.S.C.  
11 1322(n)(6)(B)) is amended by adding at the end the following: “When conducted in compliance  
12 with regulations promulgated pursuant to paragraph (4), any discharge incidental to the normal  
13 operation of a vessel of the Armed Forces is considered a federally permitted release within the  
14 meaning of section 101(10) of the Comprehensive Environmental Response, Compensation, and  
15 Liability Act of 1980 (42 U.S.C. 9601(10)), and is excluded from the definition of solid waste  
16 under section 1004(27) of the Solid Waste Disposal Act (42 U.S.C. 6903(27)).”.

#### 21 **SEC. 411. END STRENGTHS FOR SELECTED RESERVE.**

22 (a) IN GENERAL.—The Armed Forces are authorized strengths for Selected Reserve  
23 personnel of the reserve components as of September 30, 2021, as follows:

1 (1) The Army National Guard of the United States, 336,500.

2 (2) The Army Reserve, 189,800.

3 (3) The Navy Reserve, 58,800.

4 (4) The Marine Corps Reserve, 38,500.

5 (5) The Air National Guard of the United States, 108,100.

6 (6) The Air Force Reserve, 70,300.

7 (7) The Coast Guard Reserve, 7,000.

8 (b) END STRENGTH REDUCTIONS.—The end strengths prescribed by subsection (a) for the  
9 Selected Reserve of any reserve component shall be proportionately reduced by—

10 (1) the total authorized strength of units organized to serve as units of the Selected  
11 Reserve of such component which are on active duty (other than for training) at the end  
12 of the fiscal year; and

13 (2) the total number of individual members not in units organized to serve as units  
14 of the Selected Reserve of such component who are on active duty (other than for  
15 training or for unsatisfactory participation in training) without their consent at the end of  
16 the fiscal year.

17 (c) END STRENGTH INCREASES.—Whenever units or individual members of the Selected  
18 Reserve for any reserve component are released from active duty during any fiscal year, the end  
19 strength prescribed for such fiscal year for the Selected Reserve of such reserve component shall  
20 be increased proportionately by the total authorized strengths of such units and by the total  
21 number of such individual members.

22 **SEC. 412. END STRENGTHS FOR RESERVES ON ACTIVE DUTY IN SUPPORT OF**  
23 **THE RESERVES.**

1           Within the end strengths prescribed in section 411(a), the reserve components of the  
2   Armed Forces are authorized, as of September 30, 2021, the following number of Reserves to be  
3   serving on full-time active duty or full-time duty, in the case of members of the National Guard,  
4   for the purpose of organizing, administering, recruiting, instructing, or training the reserve  
5   components:

6           (1) The Army National Guard of the United States, 30,595.

7           (2) The Army Reserve, 16,511.

8           (3) The Navy Reserve, 10,215.

9           (4) The Marine Corps Reserve, 2,386.

10          (5) The Air National Guard of the United States, 25,333.

11          (6) The Air Force Reserve, 5,256.

12   **SEC. 413. END STRENGTHS FOR MILITARY TECHNICIANS (DUAL STATUS).**

13           The minimum number of military technicians (dual status) as of the last day of fiscal year  
14   2021 for the reserve components of the Army and the Air Force (notwithstanding section 129 of  
15   title 10, United States Code) shall be the following:

16          (1) For the Army National Guard of the United States, 22,294.

17          (2) For the Army Reserve, 6,492.

18          (3) For the Air National Guard of the United States, 10,994.

19          (4) For the Air Force Reserve, 7,947.

20   **SEC. 414. MAXIMUM NUMBER OF RESERVE PERSONNEL AUTHORIZED TO BE**  
21   **ON ACTIVE DUTY FOR OPERATIONAL SUPPORT.**

1           During fiscal year 2021, the maximum number of members of the reserve components of  
2 the Armed Forces who may be serving at any time on full-time operational support duty under  
3 section 115(b) of title 10, United States Code, is the following:

4           (1) The Army National Guard of the United States, 17,000.

5           (2) The Army Reserve, 13,000.

6           (3) The Navy Reserve, 6,200.

7           (4) The Marine Corps Reserve, 3,000.

8           (5) The Air National Guard of the United States, 16,000.

9           (6) The Air Force Reserve, 14,000.

10 **SEC. 415. AUTHORITIES OF SECRETARY OF DEFENSE AND SERVICE**

11 **SECRETARIES TO VARY PERSONNEL END STRENGTHS.**

12           (a) **AUTHORITY FOR SECRETARY OF DEFENSE VARIANCES.** —Section 115(f)(2) of title 10,  
13 United States Code, is amended by striking “increase” and inserting “vary”.

14           (b) **AUTHORITY FOR SERVICE SECRETARY VARIANCES.** —Section 115(g) of title 10,  
15 United States Code, is amended—

16           (1) in paragraph (1)—

17                   (A) in subparagraph (A), by striking “and” at the end; and

18                   (B) in subparagraph (B)—

19                           (i) by striking “increase” and inserting “vary”; and

20                           (ii) by striking the period at the end and inserting “; and”; and

21                   (C) by adding at the end the following:

22                   “(C) vary the end strength authorized pursuant to subsection (a)(1)(B) for a fiscal  
23 year for the Active Guard and Reserve category of the Selected Reserve of the reserve

1 component of the armed force under the jurisdiction of that Secretary or, in the case of  
2 the Secretary of the Navy, for the Active Guard and Reserve category of the Selected  
3 Reserve of the reserve component of any armed force under the jurisdiction of that  
4 Secretary, by a number equal to not more than 1 percent of such authorized end  
5 strength.”; and

6 (2) in paragraph (2)—

7 (A) in the second sentence, by striking “increase” each place it occurs and  
8 inserting “variance”; and

9 (B) by adding at the end the following new sentence: “Any variance under  
10 paragraph (1)(C) of the end strength for the Active Guard and Reserve category of  
11 the Selected Reserve of an armed force for a fiscal year shall be counted as part of  
12 the variance for that Selected Reserve for that fiscal year authorized under  
13 subsection (f)(2).”.

12 day of the first complete pay period in the following calendar year.

13           “(b) LEAVE FOR REST AND RECUPERATION.—

14           “(1) IN GENERAL.—The head of an agency may grant up to 20 days of paid leave,  
15 per leave year, to a civilian employee of the agency serving in a combat zone or other  
16 high risk, high threat post for the purposes of rest and recuperation.

17           “(2) CONVERSION OF LEAVE PERIOD INTO HOURS.—The 20 days of leave referred  
18 to in paragraph (1) shall be converted to 160 hours of leave for full-time employees and  
19 proportionally adjusted for employees with a part-time tour of duty or an uncommon tour  
20 of duty in which the hours for which leave may be charged are in excess of 80 hours in a  
21 biweekly pay period.

22           “(c) DISCRETIONARY AUTHORITY OF AGENCY HEAD.—Use of the authority under  
23 subsection (b) is at the sole and exclusive discretion of the head of the agency concerned. The

1 head of the agency may prescribe agency-wide policies to govern the use of the authority within

11 complete pay period in a calendar year and ending on the day immediately before the first  
12 day of the first complete pay period in the following calendar year.

13 “(b) LEAVE FOR LOCAL HOLIDAYS OBSERVED IN FOREIGN AREAS.—The head of an  
14 agency may grant up to 5 days of paid leave, per leave year, under this section to a civilian  
15 employee of the agency serving in a foreign area for local holidays observed in the foreign  
16 area—

17 “(1) if the head of the agency determines that the conduct of business during the  
18 local holidays would be inconsistent with host-country practice or otherwise not in the  
19 best interest of the United States; or

20 “(2) for such other reasons as the head of the agency determines necessary to  
21 advance the diplomatic interests of the United States.

22 “(c) DISCRETIONARY AUTHORITY OF AGENCY HEAD.—Use of the authority under  
23 subsection (b) is at the sole and exclusive discretion of the head of the agency concerned. The

1 head of the agency may prescribe agency-wide policies to govern the use of the authority within  
2 the agency.

3 “(d) RECORDS.—An agency shall record leave provided under this section separately  
4 from leave authorized under any other provision of law.”.

18 **ACQUISITION AND DEPLOYMENT OF CAPABILITIES NEEDED**  
19 **UNDER SPECIFIED HIGH-PRIORITY CIRCUMSTANCES.**

20 (a) REVISION AND CODIFICATION OF RAPID ACQUISITION AUTHORITY.—

21 (1) IN GENERAL.— Chapter 137 of title 10, United States Code, is amended by  
22 inserting after section 2316 the following new section:

1 **“§ 2317. Procedures for urgent acquisition and deployment of capability needed in**  
2 **response to urgent operational needs or vital national security interest**

3 “(a) PROCEDURES.—

4 “(1) IN GENERAL.—The Secretary of Defense shall prescribe procedures for the  
5 urgent acquisition and deployment of capability needed in response to urgent operational  
6 needs. The capabilities for which such procedures may be used in response to an urgent  
7 operational need are those—

8 “(A) that, subject to such exceptions as the Secretary considers appropriate  
9 for purposes of this section—

10 “(i) can be fielded within a period of two to 24 months;

11 “(ii) do not require substantial development effort;

12 “(iii) are based on technologies that are proven and available; and

13 “(iv) can appropriately be acquired under fixed price contracts; or

14 “(B) that can be developed or procured under a section 804 rapid  
15 acquisition pathway.

16 “(2) DEFINITION.—In this section, the term ‘section 804 rapid acquisition  
17 pathway’ means the rapid fielding acquisition pathway or the rapid prototyping  
18 acquisition pathway authorized under section 804 of the National Defense Authorization  
19 Act for Fiscal Year 2016 (Public Law 114-92; 10 U.S. C. 2302 note).

20 “(b) MATTERS TO BE INCLUDED.—The procedures prescribed under subsection (a) shall  
21 include the following:

1           “(1) A process for streamlined communications between the Chairman of the  
2 Joint Chiefs of Staff, the acquisition community, and the research and development  
3 community, including—

4                   “(A) a process for the commanders of the combatant commands and the  
5 Chairman of the Joint Chiefs of Staff to communicate their needs to the  
6 acquisition community and the research and development community; and

7                   “(B) a process for the acquisition community and the research and  
8 development community to propose capability that meet the needs communicated  
9 by the combatant commands and the Chairman of the Joint Chiefs of Staff.

10           “(2) Procedures for demonstrating, rapidly acquiring, and deploying a capability  
11 proposed pursuant to paragraph (1)(B), including—

12                   “(A) a process for demonstrating performance and evaluating for current  
13 operational purposes the performance of the capability;

14                   “(B) a process for developing an acquisition and funding strategy for the  
15 deployment of the capability; and

16                   “(C) a process for making deployment and utilization determinations  
17 based on information obtained pursuant to subparagraphs (A) and (B).

18           “(3) A process to determine the disposition of a capability, including termination  
19 (demilitarization or disposal), continued sustainment, or transition to a program of record.

20           “(4) Specific procedures in accordance with the guidance developed under section  
21 804(a) of the National Defense Authorization Act for Fiscal Year 2016 (Public Law 114-  
22 92; 10 U.S. C. 2302 note).



1           “(c) RESPONSE TO COMBAT EMERGENCIES AND CERTAIN URGENT OPERATIONAL

2   NEEDS.—

3           “(1) DETERMINATION OF NEED FOR URGENT ACQUISITION AND DEPLOYMENT.—

4                   “(A) In the case of any capability that, as determined in writing by the  
5           Secretary of Defense, is urgently needed to eliminate a documented deficiency  
6           that has resulted in combat casualties, or is likely to result in combat casualties,  
7           the Secretary may use the procedures developed under this section in order to  
8           accomplish the urgent acquisition and deployment of the needed capability.

9                   “(B) In the case of any capability that, as determined in writing by the  
10           Secretary of Defense, is urgently needed to eliminate a documented deficiency  
11           that impacts an ongoing or anticipated contingency operation and that, if left  
12           unfulfilled, could potentially result in loss of life or critical mission failure, the  
13           Secretary may use the procedures developed under this section in order to  
14           accomplish the urgent acquisition and deployment of the needed capability.

15                   “(C)(i) In the case of any cyber capability that, as determined in writing by  
16           the Secretary of Defense, is urgently needed to eliminate a deficiency that as the  
17           result of a cyber attack has resulted in critical mission failure, the loss of life,  
18           property destruction, or economic effects, or if left unfilled is likely to result in  
19           critical mission failure, the loss of life, property destruction, or economic effects,  
20           the Secretary may use the procedures developed under this section in order to  
21           accomplish the urgent acquisition and deployment of the needed offensive or  
22           defensive cyber capability.

1                   “(ii) In this subparagraph, the term ‘cyber attack’ means a deliberate  
2                   action to alter, disrupt, deceive, degrade, or destroy computer systems or networks  
3                   or the information or programs resident in or transiting these systems or networks.

4                   “(2) DESIGNATION OF SENIOR OFFICIAL RESPONSIBLE.—

5                   “(A)(i) Except as provided under clause (ii), whenever the Secretary  
6                   makes a determination under subparagraph (A), (B), or (C) of paragraph (1) that a  
7                   capability is urgently needed to eliminate a deficiency described in that  
8                   subparagraph, the Secretary shall designate a senior official of the Department of  
9                   Defense to ensure that the needed capability is acquired and deployed as quickly  
10                  as possible, with a goal of awarding a contract for the acquisition of the capability  
11                  within 15 days.

12                  “(ii) Clause (i) does not apply to an acquisition initiated in the case of a  
13                  determination by the Secretary that funds are necessary to immediately initiate a  
14                  project under a section 804 rapid acquisition pathway if the designated official for  
15                  acquisitions using such pathway is a service acquisition executive.

16                  “(B) Upon designation of a senior official under subparagraph (A) with  
17                  respect to a needed capability, the Secretary shall authorize that official to waive  
18                  any provision of law or regulation described in subsection (d) that such official  
19                  determines in writing would unnecessarily impede the urgent acquisition and  
20                  deployment of the needed capability. In a case in which the needed capability  
21                  cannot be acquired without an extensive delay, the senior official shall require  
22                  that an interim solution be implemented and deployed using the procedures

1 developed under this section to minimize adverse consequences resulting from the  
2 urgent need.

3 “(3) USE OF FUNDS.—

4 “(A) In any fiscal year in which the Secretary makes a determination  
5 described in subparagraph (A), (B), or (C) of paragraph (1), or upon the Secretary  
6 making a determination that funds are necessary to immediately initiate a project  
7 under a section 804 rapid acquisition pathway based on compelling national  
8 security need, the Secretary may use any funds available to the Department of  
9 Defense if the determination includes a written finding that the use of such funds  
10 is necessary to address in a timely manner the deficiency documented or  
11 identified under such subparagraph (A), (B), or (C) or the compelling national  
12 security need identified for purposes of such section 804 pathway, respectively.

13 “(B) Except as provided under subparagraph (C), the authority provided  
14 by this section may only be used to acquire capability—

15 “(i) in the case of determinations by the Secretary under paragraph  
16 (1)(A), in an amount aggregating not more than \$200,000,000 during any  
17 fiscal year;

18 “(ii) in the case of determinations by the Secretary under paragraph  
19 (1)(B), in an amount aggregating not more than \$200,000,000 during any  
20 fiscal year;

21 “(iii) in the case of determinations by the Secretary under  
22 paragraph (1)(C), in an amount aggregating not more than \$200,000,000  
23 during any fiscal year; and

1                   “(iv) in the case of a determination by the Secretary that funds are  
2                   necessary to immediately initiate a project under a section 804 rapid  
3                   acquisition pathway, in an amount aggregating not more than  
4                   \$200,000,000 during any fiscal year.

5                   “(C) For each fiscal year, the limits set forth in clauses (i) and (ii) of  
6                   subparagraph (B) do not apply to the exercise of authority under such clauses  
7                   provided that the total amount of capabilities acquired as provided under such  
8                   subparagraph does not exceed \$800,000,000 during such fiscal year.

9                   “(4) Notification to congressional defense committees.—

10                   “(A) In the case of a determination by the Secretary under paragraph  
11                   (1)(A) and (1)(C), the Secretary shall notify the congressional defense committees  
12                   of the determination within 15 days after the date of the determination.

13                   “(B) In the case of a determination by the Secretary under paragraph  
14                   (1)(B), the Secretary shall notify the congressional defense committees of the  
15                   determination at least 10 days before the date on which the determination is  
16                   effective.

17                   “(C) In the case of a determination by the Secretary under paragraph  
18                   (3)(A) that funds are necessary to immediately initiate a project under a section  
19                   804 rapid acquisition pathway, the Secretary shall notify the congressional  
20                   defense committees of the determination within 10 days after the date of the use  
21                   of such funds.

22                   “(D) A notice under this paragraph shall include the following:

23                   “(i) Identification of the capability to be acquired.

1                   “(ii) The amount anticipated to be expended for the acquisition.

2                   “(iii) The source of funds for the acquisition.

3                   “(E) A notice under this paragraph shall fulfill any requirement to provide  
4 notification to Congress for a program (referred to as a ‘new start program’) that  
5 has not previously been specifically authorized by law or for which funds have  
6 not previously been appropriated.

7                   “(F) A notice under this paragraph shall be provided in consultation with  
8 the Director of the Office of Management and Budget.

9                   “(5) LIMITATION ON OFFICERS WITH AUTHORITY.—The authority to make a  
10 determination under subparagraph (A), (B), or (C) of paragraph (1) and under paragraph  
11 (3)(A) that funds are necessary to immediately initiate a project under a section 804 rapid  
12 acquisition pathway, to designate a senior official responsible under paragraph (3), and to  
13 provide notification to the congressional defense committees under paragraph (4) may be  
14 exercised only by the Secretary or Deputy Secretary of Defense.

15                   “(d) AUTHORITY TO WAIVE CERTAIN LAWS AND REGULATIONS.—

16                   “(1) AUTHORITY.—The Secretary or Deputy Secretary of Defense, for a capability  
17 required to address the needs described in subsection (c)(1) or, upon a determination  
18 described in subsection (c)(1), and the senior official designated in accordance with  
19 subsection (c)(2), with respect to that designation, is authorized to waive any provision of  
20 law or regulation addressing—

21                   “(A) the establishment of a requirement or specification for the capability  
22 to be acquired;

1                   “(B) the research, development, test, and evaluation of the capability to be  
2                   acquired;

3                   “(C) the production, fielding, and sustainment of the capability to be  
4                   acquired; or

5                   “(D) the solicitation, selection of sources, and award of the contracts for  
6                   procurement of the capability to be acquired.

7                   “(2) LIMITATIONS.—Nothing in this subsection authorizes the waiver of—

8                   “(A) the requirements of this section;

9                   “(B) any provision of law imposing civil or criminal penalties; or

10                  “(C) any provision of law governing the proper expenditure of  
11                  appropriated funds.

12                  “(e) OPERATIONAL ASSESSMENTS.—

13                  “(1) The process prescribed under subsection (b)(2)(A) for demonstrating  
14                  performance and evaluating the current operational performance of a capability proposed  
15                  pursuant to subsection (b)(1)(B) shall include the following:

16                  “(A) An operational assessment in accordance with procedures prescribed  
17                  by the Director of Operational Test and Evaluation.

18                  “(B) A requirement to provide information about any deficiency of the  
19                  capability in meeting the original requirements for the capability (as stated in a  
20                  statement of the urgent operational need or similar document) to the deployment  
21                  decision-making authority.

1           “(2) The process may not include a requirement for any deficiency of capability  
2 identified in the operational assessment to be the determining factor in deciding whether  
3 to deploy the capability.

4           “(3) If a capability is deployed under the procedures prescribed pursuant to this  
5 section, or under any other authority, before operational test and evaluation of the  
6 capability is completed, the Director of Operational Test and Evaluation shall have access  
7 to operational records and data relevant to such capability in accordance with section  
8 139(e)(3) of this title for the purpose of completing operational test and evaluation of the  
9 capability. Such access shall be provided in a time and manner determined by the  
10 Secretary of Defense consistent with requirements of operational security and other  
11 relevant operational requirements.”.
