Section-by-Section Analysis

Errantly or maliciously operated unmanned aircraft increase risks to the Department's installations, activities, and personnel. This proposal would make several amendments to section 130i of title 10, U.S. Code, to clarify and strengthen this authority to mitigate the threat that an unmanned aircraft system or unmanned aircraft poses to the safety or security of a covered Department of Defense (DoD) facility or asset.

This proposal would permit the Secretary of Defense to authorize contractor personnel performing functions under contract with the Department of Defense that include safety, security, or protection of a Government-owned, contractor-operated facility, and who are trained and certified to perform such duties, to take the actions described in (b)(1). The Departments of the Army, Navy, and Air Force are responsible for Government-owned, contractor-operated facilities that produce munitions and other sensitive items. In the absence of this change, the Departments of the Army, Navy, and Air Force would have to either assign members of the armed forces and officers and civilian employees of the Department of Defense at such facilities or accept that these facilities will remain vulnerable.

This proposal would amend subsection (a) by authorizing the Secretary of Defense to take such actions described in subsection (b)(1), as developed in coordination with the Secretary of Transportation, that are necessary to mitigate the threat (as defined by the Secretary of Defense, in consultation with the Secretary of Transportation) that an unmanned aircraft system or unmanned aircraft poses to the safety or security of a temporarily covered facility or asset. A DoD facility or asset that is not directly associated with a covered mission can temporarily be at high risk of loss due to a specific, highly significant vulnerability (e.g., a port of embarkation for military personnel deploying by ship to conduct combat operations in an overseas conflict) or specific intelligence or law enforcement information that such a facility or asset is a target for hostile action. As with any other covered facility or asset, a temporarily covered facility or asset would also be subject to the statutorily required coordination between the Secretary of Defense and the Secretary of Transportation concerning actions, as required by subsection (b)(2). The authority to mitigate the threat posed to a temporarily covered facility or asset would enable the Secretary of Defense to adapt to emerging vulnerabilities and threats in a timely manner, but only for the duration of the emerging high risk. In the absence of such an authority, the

Department's personnel would have to resort to alternative, potentially less effective mitigating actions (e.g., request that the Federal Aviation Administration establish temporary flight restrictions, which could highlight the facility or asset as a high interest target to an adversary), if available, or to take necessary actions, even though they may be exposed to legal jeopardy.

This proposal would amend the partial termination subsection (i.e., subsection (j), as redesignated) to extend the date of termination from December 31, 2023, to December 31, 2025. This extension would facilitate planning, programming, and budgeting across the Future Years Defense Program to develop, test, and field capabilities and operations necessary to protect the Department's facilities and assets in the United States. This extension would also enable the Department to rely more on capabilities designed for use in the United States rather than capabilities designed for use in military operations abroad. In addition, this proposal would modify the presidential extension from 180 days to one year. As a practical matter, the current 180-day extension would merely extend the protection of the covered facilities or assets specified in clauses (iv) through (viii) of subsection (k)(3), as redesignated, to May of the following year. This likely would result in a gap in protection from May until such time as a subsequent national defense authorization act enacted into law. Based on the date of enactment of the last 20 national defense authorization acts, this gap in authority would extend from October to January of the next year.

This proposal would amend subsection (k)(3)(C) by updating the definition of a covered facility or asset to include a facility or asset by adding clause (x), a military airport or airfield that is not intended to be temporary. Errantly or maliciously operated UAS in the United States create a flight hazard to military aircraft operations and training. Including permanent military airports and airfields would extend the authority provided by section 130i to encompass permanent military airports and airfields not associated with the missions specified by this section.

Changes to Existing Law: This proposal would amend section 130i of title 10, United States Code, as follows:

§ 130i. Protection of certain facilities and assets from unmanned aircraft

- (a) AUTHORITY.—Notwithstanding section 46502 of title 49, or any provision of title 18, the Secretary of Defense may take, and may authorize members of the armed forces and officers, and civilian employees of the Department of Defense covered personnel with assigned duties that include safety, security, or protection of personnel, facilities, or assets, to take, such actions described in subsection (b)(1) that are necessary to mitigate the threat (as defined by the Secretary of Defense, in consultation with the Secretary of Transportation) that an unmanned aircraft system or unmanned aircraft poses to the safety or security of a covered facility or asset or a temporarily covered facility or asset for the duration of the period in which the temporarily covered facility is at high risk or a potential target.
 - (b) ACTIONS DESCRIBED.—(1) The actions described in this paragraph are the following:
 - (A) Detect, identify, monitor, and track the unmanned aircraft system or unmanned aircraft, without prior consent, including by means of intercept or other access of a wire communication, an oral communication, or an electronic communication used to control the unmanned aircraft system or unmanned aircraft.
 - (B) Warn the operator of the unmanned aircraft system or unmanned aircraft, including by passive or active, and direct or indirect physical, electronic, radio, and electromagnetic means.
 - (C) Disrupt control of the unmanned aircraft system or unmanned aircraft, without prior consent, including by disabling the unmanned aircraft system or unmanned aircraft by intercepting, interfering, or causing interference with wire, oral, electronic, or radio communications used to control the unmanned aircraft system or unmanned aircraft.
 - (D) Seize or exercise control of the unmanned aircraft system or unmanned aircraft.
 - (E) Seize or otherwise confiscate the unmanned aircraft system or unmanned aircraft.
 - (F) Use reasonable force to disable, damage, or destroy the unmanned aircraft system or unmanned aircraft.
- (2) The Secretary of Defense shall develop the actions described in paragraph (1) in coordination with the Secretary of Transportation.
- (c) FORFEITURE.—Any unmanned aircraft system or unmanned aircraft described in subsection (a) that is seized by the Secretary of Defense is subject to forfeiture to the United States.

- (d) REGULATIONS AND GUIDANCE.—(1) The Secretary of Defense and the Secretary of Transportation may prescribe regulations and shall issue guidance in the respective areas of each Secretary to carry out this section.
- (2)(A) The Secretary of Defense and the Secretary of Transportation shall coordinate in the development of guidance under paragraph (1).
- (B) The Secretary of Defense shall coordinate with the Secretary of Transportation and the Administrator of the Federal Aviation Administration before issuing any guidance or otherwise implementing this section if such guidance or implementation might affect aviation safety, civilian aviation and aerospace operations, aircraft airworthiness, or the use of airspace.
- (e) PRIVACY PROTECTION.—The regulations prescribed or guidance issued under subsection (d) shall ensure that—
 - (1) the interception or acquisition of, or access to, an unmanned aircraft system or communications to or from an unmanned aircraft system under this section is conducted in a manner consistent with the fourth amendment to the Constitution and applicable provisions of Federal law;
 - (2) communications to or from an unmanned aircraft system are intercepted, acquired, or accessed only to the extent necessary to support a function of the Department of Defense;
 - (3) records of such communications are not maintained for more than 180 days unless the Secretary of Defense determines that maintenance of such records—
 - (A) is necessary to support one or more functions of the Department of Defense; or
 - (B) is required for a longer period to support a civilian law enforcement agency or by any other applicable law or regulation; and
 - (4) such communications are not disclosed outside the Department of Defense unless the disclosure—
 - (A) would fulfill a function of the Department of Defense;
 - (B) would support a civilian law enforcement agency or the enforcement activities of a regulatory agency of the Federal Government in connection with a criminal or civil investigation of, or any regulatory action with regard to, an action described in subsection (b)(1); or
 - (C) is otherwise required by law or regulation.
- (f) BUDGET.—The Secretary of Defense shall submit to Congress, as a part of the defense budget materials for each fiscal year after fiscal year 2018, a consolidated funding display that identifies the funding source for the actions described in subsection (b)(1) within the Department of Defense. The funding display shall be in unclassified form, but may contain a classified annex.
- (g) SEMIANNUAL BRIEFINGS.—(1) On a semiannual basis during the five-year period beginning March 1, 2018, the Secretary of Defense and the Secretary of Transportation, shall jointly provide a briefing to the appropriate congressional committees on the activities carried out pursuant to this section. Such briefings shall include—

- (A) policies, programs, and procedures to mitigate or eliminate impacts of such activities to the National Airspace System;
- (B) a description of instances where actions described in subsection (b)(1) have been taken;
- (C) how the Secretaries have informed the public as to the possible use of authorities under this section; and
- (D) how the Secretaries have engaged with Federal, State, and local law enforcement agencies to implement and use such authorities.
- (2) Each briefing under paragraph (1) shall be in unclassified form, but may be accompanied by an additional classified briefing.
 - (h) RULE OF CONSTRUCTION.—Nothing in this section may be construed to—
 - (1) vest in the Secretary of Defense any authority of the Secretary of Transportation or the Administrator of the Federal Aviation Administration under title 49; and
 - (2) vest in the Secretary of Transportation or the Administrator of the Federal Aviation Administration any authority of the Secretary of Defense under this title.
- (i) LIMITATION ON ACTIVITIES BY CONTRACTOR PERSONNEL AND OVERSIGHT.—In carrying out this section, the Secretary shall ensure that—
 - (1) contractor personnel are not directed or permitted to perform any action that is an inherently governmental function as that term is defined in the Federal Activities

 Inventory Reform Act of 1998 (31 U.S.C. 501 note; Public Law 105–270); and
 - (2) the Department conducts appropriate oversight of contract personnel.
- (ij) Partial Termination.—(1) Except as provided by paragraph (2), the authority to carry out this section with respect to the covered facilities or assets specified in clauses (iv) through (viii) of subsection (j)(3)(C) shall terminate on December 31, 2023 December 31, 2025.
- (2) The President may extend by 180 days one year the termination date specified in paragraph (1) if before November 15, 2023 November 15, 2025, the President certifies to Congress that such extension is in the national security interests of the United States.
 - $(j\underline{k})$ DEFINITIONS.—In this section:

Section-by-Section Analysis

This proposal would amend section 2218 of title 10, United States Code, to provide the Secretary of Defense with the discretionary authority to purchase used, foreign built sealift ships without the accompanying requirement to procure 10 new sealift vessels in U.S. shipyards. This proposal would also waive the requirement for a new construction sealift vessel to be delivered by 2028. This authority will allow the Secretary of Defense to recapitalize surge sealift capability in the near term with used commercial ships, allowing the Department to align new construction acquisition with the projected retirement of vessels aging out of the Maritime Prepositioning Force (MPF), with delivery of a lead-new construction in 2029.

Over 50% of the Surge Sealift vessels are approaching the end of their service life in the next 10 years. By increasing the buy used authority, the Department can accelerate the path to recapitalize the Surge Sealift fleet immediately. Allowing the Secretary of Defense to increase the number of foreign built used vessels to replace ships reaching the end of service life maintains an acceptable level of capacity risk to meet lift requirements. As reflected in the Business Case Analysis For the Recapitalization of The Ready Reserve Force, Report to Congress (January 2019), the recapitalization of surge sealift capability with used commercial ships is the most cost effective and efficient method to maintain required capability.

In order to achieve the timeline for a new construction MPF lead ship, developing the prepositioning requirement(s) and design and acquisition processes will drive an anticipated delivery in time to support retirement of the first ship in 2030. Therefore, the legislative proposal removes the current statutory timeline to enable the immediate recapitalization of surge sealift capacity at a pace that will keep up with ships reaching the end of service life.

Increasing the authority to buy used, foreign ships will not impact the Department's comprehensive commitment to fund and build new construction auxiliary ships in the United States. The 30-year Ship Building Plan details the procurement and delivery of several new construction auxiliary shipbuilding procurement programs: T-AO 205, Next Generation Logistics Ship (NGLS), T-EPF, T-ATS 6, T-AGOS(X), and AS(X). For these programs, the Navy's Dec 2020 Plan depicts procurement of 30 ships by FY2026. Additionally, the Navy's Dec 2020 Plan depicts a plan for 10 Non-Battle Force new construction auxiliary and sealift ships by FY2028. The United States industrial base continues to be the fundamental enabler for

achieving and sustaining the Navy's future fleet. Our shipbuilding and supporting vendor base constitute a national security imperative that must be steadily supported, and grown, to maintain a skilled workforce. Consistent commitment to steady acquisition is required to ensure the U.S. industrial supplier base achieves the capability and capacity required to build and maintain the Navy's future fleet. The Navy welcomes an opportunity to brief Congress on the Navy's auxiliary shipbuilding plan.

Budget Implications: If enacted this proposal would not increase the budgetary requirements of the DoD. Funds to purchase the used vessels authorized by this proposal are included in the Navy's FY 2022 Shipbuilding and Conversion Budget. Final budget estimates will be highly dependent on availability of suitable ships, market conditions, material condition, size, and overall military utility.

Changes to Existing Law: This proposal would make the following changes to section 2218 of title 10, United States Code:

§ 2218. National Defense Sealift Fund

(a) ESTABLISHMENT.—There is established in the Treasury of the United States a fund to be known as the "National Defense Sealift Fund".

* * * * *

- (f) LIMITATIONS.—(1) A vessel built in a foreign ship yard may not be purchased with funds in the National Defense Sealift Fund pursuant to subsection (c)(1), unless specifically authorized by law.
- (2) Construction, alteration, or conversion of vessels with funds in the National Defense Sealift Fund pursuant to subsection (c)(1) shall be conducted in United States ship yards and shall be subject to section 1424(b) of Public Law 101-510 (104 Stat. 1683).
- (3) (A) Notwithstanding the limitations in subsections (c)(1)(D) and (1), the Secretary of Defense may, as part of a program to recapitalize the Ready Reserve Force component of the National Defense Reserve Fleet and the Military Sealift Command surge fleet, purchase any used vessels, regardless of where such vessel was constructed if such vessel
 - (i) participated in the Maritime Security Fleet; and
 - (ii) is available for purchase at a reasonable cost, as determined by the Secretary.

- (B) If the Secretary determines that no used vessel meeting the requirements under clause (i) and (ii) of subparagraph (A) is available, the Secretary may purchase a used vessel comparable to a vessel described in clause (i) of subparagraph (A), regardless of the source of the vessel or where the vessel was constructed, if such vessel is available for purchase at a reasonable cost, as determined by the Secretary.
- (C) The Secretary may not use the authority under this paragraph to purchase more than nine foreign constructed vessels.
- (<u>DC</u>) The Secretary shall ensure that the initial conversion, or modernization of any vessel purchased under the authority of subparagraph (A) occurs in a shippard located in the United States.
- (E) The Secretary may not use the authority under this paragraph to procure more than four foreign constructed vessels unless the Secretary submits to Congress, by not later than the second week of February of the fiscal year during which the Secretary plans to use such authority, a certification that—
 - (i) the Secretary has initiated an acquisition strategy for the construction in United States shippards of not less than ten new vessels that are sealift vessels, auxiliary vessels, or a combination of such vessels; and
 - (ii) of such new vessels, the lead ship is anticipated to be delivered by not later than 2028.
- (FD) Not later than 30 days before the purchase of any vessel using the authority under this paragraph, the Secretary, in consultation with the Maritime Administrator, shall submit to the congressional defense committees a report that contains each of the following with respect to such purchase:
 - (i) The proposed date of the purchase.
 - (ii) The price at which the vessel would be purchased.
 - (iii) The anticipated cost of modernization of the vessel.
 - (iv) The proposed military utility of the vessel.
 - (v) The proposed date on which the vessel will be available for use by the Ready Reserve.
 - (vi) The contracting office responsible for the completion of the purchase.
 - (vii) Certification that—
 - (I) there was no vessel available for purchase at a reasonable price that was constructed in the United States; and
 - (II) the used vessel purchased supports the recapitalization of the Ready Reserve Force component of the National Defense Reserve Fleet or the Military Sealift Command surge fleet.
 - (viii) A detailed account of the criteria used to make the determination under subparagraph (B).
- (G) The Secretary may not finalize or execute the final purchase of any vessel using the authority under this paragraph until 30 days after the date on which a report under subparagraph (F) is submitted with respect to such purchase.

Section-by-Section Analysis

This proposal would fill a gap in the United States' ability to lead and administer the United Nations Command (UNC). Currently, DoD lacks affirmative legal authority to spend U.S. appropriated funds for unreimbursed logistical support to foreign military members assigned as staff officers to the UNC Staff, United Nations Command-Rear (UNC-R), the United Nations Command Military Armistice Commission (UNCMAC), the United Nations Command Honor Guard (UNC-HG), or the Neutral Nations Supervisory Commission (NNSC).

Foreign countries supporting UNC, also called "Sending States", participate with UNC under the auspices of United Nations Security Council Resolution 84 (dated 7 July 1950), which asks countries of the UN to provide military forces to UNC to restore international peace and security on the Korean peninsula. Under the current UNC mission, these forces integrate into the UNC force structure as staff officers to plan and execute that mission, which is different from partner capacity-building programs involving foreign exchange or liaison officers.

Since 1975, the Department of the Army has been designated by the Chairman, Joint Chiefs of Staff, as the U.S. Executive Agent for logistical support for U.S. forces in UNC; however, no funds have been authorized or appropriated for logistical support to foreign forces in UNC. Historically, UNC Sending States provided or paid for their own logistical support

during hostilities and the early years following the Armistice. Soon thereafter, the U.S. military began providing unreimbursed logistical support to all foreign forces serving as part of the UNC. UNC operations are currently funded by USFK budgeted Operation and Maintenance, Army (OMA) appropriations. OMA appropriations are for paying the expenses, not otherwise provided for, needed for the current operations and maintenance of the U.S. forces, but not the foreign armed forces, of UNC.

Under U.S. law, appropriated funds may only be spent for purposes authorized by Congress. Congress has not authorized spending DoD funds to provide unreimbursed logistical support to foreign forces within UNC or NNSC. The only current applicable authorization for DoD to provide logistical support directly to foreign military forces in UNC (outside of the Foreign Military Sales process or the exchange/liaison programs authorized by 10 U.S.C. §§311-312) is on a fully reimbursable basis, through the use of existing Acquisition and Cross-Servicing Agreements. These authorities do not envision the situation of a Sending State staff officer integrated into U.S. command staff billets at all echelons of command from the Deputy Commander on down, in substantial numbers, and from a wide diversity of nations. These staff officers would not function as liaison officers or exchange officers, and would participate solely for the benefit of UNC, not for a capacity building or security cooperation purpose.

As such, this proposal includes: (1) the authority to provide broad administrative services and support (including housing, temporary duty (TDY) expenses, and daily operating costs) to NNSC and UNC foreign military forces; (2) the authority to provide subsistence and medical care to UNC foreign military forces from developing nations; and (3) the discretion to provide such logistical support on a reimbursed or unreimbursed basis. UNC relies on broad international commitment to maintain the Armistice and simultaneous readiness, if called upon, to receive, stage, and deploy Sending State forces in response to conflict on the Korean Peninsula. Providing unreimbursed logistical support benefits the U.S. in securing the participation of other countries in UNC/NNSC and enhances the operational capability of UNC in order to contribute to the defense of the Republic of Korea.

For purposes of this proposal, the term "developing country," per 10 U.S.C. §301(4), section 1241(n) of the National Defense Authorization Act for Fiscal Year 2017, and the Under Secretary of Defense for Policy Memorandum of 15 May 2017 titled "Definition of 'Developing Country' for Security Cooperation Programs" would be defined as all low and middle income countries based on gross national income per capita as published annually in the World Bank list of economies.
